DIRECTIONS FOR USE: It is recommended that compatibility be checked in individual formulations. Typical applications and suggested concentrations are:

LATEX EMULSIONS	0.03 – 0.075%
AQUEOUS BASED PAINTS	0.03 – 0.25%
METAL WORKING FLUIDS	0.015 – 0.25%
AQUEOUS MINERAL SLURRIES	0.04 – 0.25%
AQUEOUS-BASED CLEANING PRODUCTS	0.03 – 0.25%

FIRST AID:

IF SWALLOWED: Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

IF ON SKIN OR CLOTHING: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice.

IF INHALED: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

IF IN EYES: hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

Take container, label or product name and pest control product registration number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION: Probable mucosal damage may contraindicate the use of gastric lavage. Measures against circulatory shock, respiratory depression and convulsion may be needed. Treat symptomatically.

DISPOSAL:

1. Triple or pressure rinse the empty container. Add the rinsings to treatment site.
