Routine application will not only clean the carpets, but sanitize and deodorize for a clean, longer lasting carpet. CARPET SANITIZER CS-202 is a low foaming carpet shampoo formula for use with extraction and carpet steam cleaning equipment. CARPET SANITIZER CS-202 contains "twin-chain" quaternary ammonium compounds to reduce the growth of odour causing bacteria. CARPET SANITIZER CS-202 is fortified to neutralize unpleasant odours. Formulated for use on commercial washable synthetic fibres. **{Not recommended for use on wool carpets}**. CARPET SANITIZER CS-202 effectively and economically lifts and removes greasy soil, resists resoiling, and utilizes "built-in" defoamers for more productive use. CARPET SANITIZER CS-202 is a balanced formulation combining true odor counteractants, a non-ionic synthetic detergent, a quaternary ammonium compound, organic chelating agents and synergizing builders for effective carpet cleaning, sanitizing and counteracting of odours when used as directed.

DIRECTIONS FOR USE

TO CLEAN, SANITIZE AND DEODORIZE CARPETS.

Steam Extraction: Vacuum carpet thoroughly. Mix 16 mL of CARPET SANITIZER CS-202 per litre of water. Inject and extract as you would any steam cleaning shampoo.

Spin Bonnet (Bonnet Buff) Cleaning: Vacuum carpet thoroughly. Mix 32 mL of CARPET SANITIZER CS-202 per litre of water. Spray on carpet at rate of 4.9 - 7.4 m²/Litre. (Alternate direction).

Heavy Duty Spin Bonnet (Bonnet Buff) Cleaning: Vacuum carpet thoroughly. Mix 125 mL of CARPET SANITIZER CS-202 per litre of water. Spray on carpet at rate of 4.9 - 7.4 m²/Litre.

NOTE: Test colour fastness of carpet before use. Apply diluted cleaner to a small concealed spot, then rub with clean white cloth. If colour transfers to cloth or changes, a water base product should not be used. Not recommended for use on Stain-Resistant Nylon Carpets. Consult carpet manufacturer's warranty and maintenance instructions for proper use. After cleaning, set carpet pile in one direction with a stiff brush. Place aluminium foil under legs of furniture while carpet is drying. Over-wetting can cause shrinking of carpet. Manufacturer assumes no responsibility for over-wetting or misuse

FIRST-AID:
