DIRECTIONS FOR USE: To be used only in the manufacture of a herbicide which is registered under the PEST CONTROL PRODUCTS ACT.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN AND PREVENT ACCESS BY UNAUTHORIZED PERSONNEL. Harmful in contact with skin and if swallowed. Irritating to eyes. Avoid contact with skin and eyes or inhalation of dust particles. Wear protective gloves and face shield when handling. Remove any contaminated clothing immediately. Wash hands and exposed skin thoroughly after handling.

FIRST AID: If swallowed: Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

If on skin or clothing: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15 to 20 minutes. Call a poison control centre or doctor for treatment advice.

If inhaled: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

If in eyes: Hold eye open and rinse slowly and gently with water for 15 to 20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION: No specific antidote is available. Treat symptomatically.

STORAGE:

Store in original container in a well ventilated, cool, dry and secure area. Do not contaminate, ship with or store near food, feed, or seed. Keep away from fire, open flame, or other sources of heat.

DISPOSAL: Canadian formulators using this product should dispose of unwanted active ingredient and containers in accordance with municipal or provincial regulations. For additional details and information on clean up of spills, contact the provincial regulatory agency and the manufacturer.

SPILLAGE CLEAN-UP:

Contact the manufacturer and the provincial regulatory agency in case of a spill, and for clean-up of spills. Keep by-standers away. Do not smoke, drink or eat during clean-up operations. Wear protective equipment (respirator, coveralls, rubber boots and protective gloves) and sweep up all product and shovel into a drum. Dampen spilled product and use absorbent sweeping compound to prevent dust. Add broken packages to the drum and seal for removal to an approved disposal site.

Wash spill site with water and mop up into a drum for disposal to an approved disposal site. Remove and wash all protective clothing and equipment.
