GENERAL INFORMATION

Lenvyor is a broad-spectrum fungicide containing the active ingredient mefentrifluconazole. For optimum disease management, apply **Lenvyor** in a regularly scheduled protective spray program and use in a rotation program with non-Group 3 fungicides.

MODE OF ACTION

Mefentrifluconazole, the active ingredient in **Lenvyor**, inhibits demethylation of sterol biosynthesis (DMI), which disrupts cell membrane synthesis and is classified by the Fungicide Resistance Action Committee (FRAC) as a Group 3 fungicide.

MIXING

Aerial Application

Ensure thorough coverage of foliage. Consult nozzle manufacturers recommendation for spray pressures for specific nozzles.

Instructions for Aerial Applications

Apply only by fixed-wing or rotary aircraft equipment which has been functionally and operationally calibrated for the atmospheric conditions of the area and the application rates and conditions of this label. Label rates, conditions and precautions are product specific. Read and understand the entire label before opening this product. Apply only at the rate recommended for aerial application on this label. Where no rate for aerial application appears for the specific use, this product cannot be applied by any type of aerial equipment. Ensure uniform application. To avoid streaked, uneven or overlapped application, use appropriate marking devices.

Use Precautions

Apply only when meteorological conditions at the treatment site allow for complete and even crop coverage. Apply only under conditions of good practice specific to aerial application as outlined in the National Aerial Pesticide Application Manual, developed by the Federal/Provincial/Territorial Committee on Pest Management and Pesticides.

Do not allow the pilot to mix chemicals to be loaded onto the aircraft. Loading of premixed chemicals with a closed system is permitted. It is desirable that the pilot have communication capabilities at each treatment site at the time of application. The field crew and the mixer/loaders must wear chemical-resistant gloves, coveralls over a long-sleeved shirt and long pants, socks and chemical-resistant footwear and goggles or face shield during mixing/loading, clean-up and repair. For resistance management, please note that **Lenvyor** contains a Group 3 fungicide. Any fungal population may contain individuals naturally resistant to **Lenvyor** and other Group 3, fungicides. A gradual or total loss of pest control may occur over time if these fungicides are used repeatedly in the same locations. Other resistance mechanisms that are not linked to site of action but are

specific for individual chemicals, such as enhanced metabolism, may also exist. Appropriate resistance-management strategies should be followed.

To delay fungicide resistance:

- Where possible, rotate the use of **Lenvyor** with a fungicide from a different mode of action group other than group 3 that controls the same pathogens. **DO NOT** exceed the total number of applications of **Lenvyor** per season as stated in the Crop-Specific tables.
- Fungicide use should be based on an IPM program that includes scouting, historical information related to pesticide use and crop rotation and considers host plant resistance, impact of environmental conditions on disease development, disease thresholds, as well as cultural, biological and other chemical control practices.
- Where possible, make use of predictive disease models to effectively time fungicide applications.
- Monitor treated fungal populations for resistance development. Notify BASF if reduced sensitivity of the pathogen to **Lenvyor** is suspected.
