## **PRECAUTIONS**

### **PREVENT ACCESS BY UNAUTHORIZED PERSONNEL**

Harmful if swallowed, inhaled or absorbed through the skin. Avoid breathing dust and contact with skin or eyes. The active ingredient trifluralin may cause skin sensitization reactions in certain individuals. Wear goggles and protective clothing such as coveralls, a long-sleeved shirt and impermeable gloves when handling this product.

### **FIRST AID**

**Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.**

**If swallowed:** Call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

**If on skin or clothing:** Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control centre or doctor for treatment advice.

**If inhaled:** Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

**If in eyes:** Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

### **TOXICOLOGICAL INFORMATION**

No specific antidote. Employ supportive care. Treatment should be based on judgment of the physician in response to reactions of the patient.

### **AGRICULTURAL CHEMICAL**

Do not ship or store with food, feeds, drugs or clothing.

### **ENVIRONMENTAL HAZARDS**

Direct contamination of any body of water with this product may kill fish. Do not contaminate any body of water by direct application, cleaning of equipment or disposal of wastes.

### **STORAGE**

Keep in original container during storage. Store product in cool, dry, well ventilated place away from seed, feed, fertilizer, or other pesticides. Keep away from fire or open flame, or other source of heat.

### **DISPOSAL**

Completely empty fibre drum by shaking and tapping sides and bottom to loosen clinging particles. Empty residue into manufacturing equipment. Do not reuse the container. Make the container unsuitable for further use and dispose in accordance with provincial requirements. Canadian formulators of this technical should dispose of unwanted active ingredient and containers in accordance with municipal or provincial regulations. For information on disposal of unused, unwanted product, contact the manufacturer or the provincial regulatory agency. Contact the manufacturer and the provincial regulatory agency in case of a spill, and for clean-up of spills.

**DIRECTIONS FOR USE**

To be used only in the manufacture of a herbicide which is registered under the *Pest Control Products Act*. Formulations containing trifluralin may require precautionary labelling differing from that given.
