NOTICE TO USER

This pest control product is to be used only in accordance with the directions on the label. It is an offence under the Pest Control Products Act to use this product in a way that is inconsistent with the directions on the label.

FIRST AID

If on skin or clothing, take off contaminated clothing. Rinse skin immediately with plenty of water for 15–20 minutes. Call a poison control centre or doctor for treatment advice.

If in eyes, hold eye open and rinse slowly and gently with water for 15–20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor for treatment advice.

If swallowed, call a poison control centre or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control centre or doctor. Do not give anything by mouth to an unconscious person.

If inhaled, move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible. Call a poison control centre or doctor for further treatment advice.

Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

TOXICOLOGICAL INFORMATION

No specific antidote is available. Apply symptomatic therapy. If ingested, check for possible mucosal damage before administering gastric lavage.

PRECAUTIONS

PREVENT ACCESS BY UNAUTHORIZED PERSONNEL.

Strictly observe all precautions for handling and using pesticides. Avoid contact with skin, eyes and clothing. Do not contaminate food, feed or water supplies. Wear chemical resistant gloves and goggles or a face shield when handling the product.

STORAGE

Store in original container in a well-ventilated, cool, dry, and secure area. Ship and store away from food, feed or seed. Keep containers tightly closed. **KEEP OUT OF REACH OF CHILDREN, UNAUTHORIZED PERSONNEL and domestic animals.** Prevent eating, drinking, tobacco usage, and cosmetic application in areas where there is a high potential for exposure to the material. Always wash thoroughly after handling.
